2. Approval of Minutes from the previous meeting - unanimously

- 3. Guest Speaker Dr. Alfred Abuhamad, Dean, President and Provost
  - Voiced importance of the faculty senate for governance and progress of the school. Sustainability of resources to allow EVMS to expand on what is already being done.
  - 2. Rebuilding relationships Sentara relationship has improved, supporting school of public health, focus on substance abuse in pregnancy as well
  - 3. Met with governor and several legislators
  - 4. Internal study working with consultant to help identify needs, threats/challenges to allow school to obtain resources. Chair recruitment, faculty salaries, clinical rotations for students are some universal issues. Has approached Dept. Chairs to identify on departmental level.
  - 5. State financial support Base adequacy looking for funding on par with other institutions. EVMS base adequacy is 95% of other schools. Money for school of public health. Capital projects HVAC system update, digital cameras for safety, funding for FM residency, maintenance for Waitzer Hall.
  - 6. Process for partnership negotiation: BOV engaging consultant Chartis Group
    - i. Internal/external process

- iii. Financial support from state/Sentara
- 7. Sentara affiliation agreement expires in 2022, starting negotiations soon, Dr. Abuhamad asked to include mission-driven priorities
- 8. Coordinate and expand activities with regards to health disparities in community building on work already done
- 9. Office of Equity/health disparities Dr. Abuhamad envisions creating this, would coordinate efforts across campus
- 10. Question re: CHKD relationship: reaching out to leadership (Mr. Dahling)
- 11. Met with CEO of Chesapeake Regional Medical Center looking at establishing residency programs, collaboration with departments e.g. ENT
- 12. CEO of Riverside again looking for collaborations.
- 13. Portsmouth Naval proposed to contact.
- 14. Dental services offer clerkships in CHKD clinics?
- 15. Strategic planning for research in basic science departments met with physiology, meetings upcoming for other departments
- 16. HP concerns working on rotation availability for PA students; EVMS culture/wellness considering making wellness officer a full-time position. Identified resources as at least part of the issue.
- 17. Staff compensation an issue as well. Related his own history with this issue.

Additional items - International travel - reviewed by committee, preventing
international travel for professional reasons due to pandemic. Asking Dr. Combs
to adhere to CDC guidance, consider case by case. Consider allowing
professional travel (e.g. presentation at conference) to destinations CDC
considers safe if faculty are vaccinated.

  - 2. New question re: wellness how can extend support to community faculty, also setting of COVID
    - i. E.g. departments like peds, radiology, urology, neurology, ED who are non-salaried core faculty; Virtual resources - refresher re: specific resources available
    - ii. Consider best way to gather input faculty and staff
    - iii. HR difficult to get right person on the phone to answer questions or who to go to for which topics; difficulty getting response, then email/call Matt Schenk if issues; recruiting/retaining staff; reconstitute fringe benefits committee with fac senate representation; change in faculty notice to 3 months - not posted, no fac senate input communicate with Dr. Mylona. Should come to senate BEFORE approval
    - iv. Communications website improvements, especially updating in real time e.g. setting of residency interviews with applicants
