Research at EVMS an Overview – Presentation by Dr. William Wasilenko	 For the past 10 years funding of sponsored programs have ranged between 35 to 44 million dollars; with half of this amount coming from CONRAD NIH funding only around 2.5 million; age of first time NIH awardees in early-mid 40's; NIH funding amounts are being reduced Reinstitution of Intramural Funding to promote development of research that can be bridge to outside (federal funding); this year budget \$250K for awards; application guidelines are posted on the Office of Research's webpage 	 Leading research areas that are being promoted by the school: Diabetes/Obesity, Cancer, Women and Infant Health, and Community Health – Faculty need to leverage research in these areas and seek collaborative partners internal and external EVMS is part of a State Research Consortium for the purpose of expanding our capacity to develop and identify research initiative with other VA academic institutions and compete for larger grants
