- B. Meeting with Dean Homan/Dean's Executive council
- 1. LCME update: Visit scheduled for Oct 2012. Faculty were encouraged to volunteer to help if asked by Dr. Flenner. Some Student Counseling and Course issues being addressed.
- 2. Appointment/Promotions: Dean is forming a Task Force to address criteria/classifications.
- 3. Faculty evaluations: Helpful feedback from Senate forwarded. LCME requirement to do this. Goal is to implement July 1, 2012.
- 4. Legislative update: Awaiting results of General Assembly approval of Gov. McDonnell's budget allocation of extra funding for EVMS.
- 5. Associate Dean of Faculty Affairs: Dean is making this a priority to add to his office.
- 6. Faculty Salaries: Dr. Krishna discussed the disparities between ranks and between departments with respect to clinical and PhD faculty salaries. Dean is acutely aware and is working on solutions.
- 7. Lack of seed money for translational research: Dr. Krishna emphasized the need to provide this to faculty to improve their ability to compete for extramural funding.
- 8. Reducing bureaucracy: Theme relevant to discussions regarding the IRB, Office of Research and Sponsored Programs.
- C. Finance Committee:
- 1. YTD finances are better than budgeted for first 6 months of fiscal year.
- 2. Holding to our bond covenants.
- 3. Revisions made to policy regarding use of departmental funds to honor employees, fund retirement parties etc.
- 4. Initial discussions at the Finance Committee level regarding the Dean's Tax and potential future changes to the formula.
