- III. Old business
 - A. Advancement and Promotions Committee: The Dean will be meeting with incoming Faculty Senate President David Archer and outgoing President Neel Krishna to discuss the comments collected from the Faculty (distributed via email by Dr. Krishna). The documents are headed to the Chairs for their review.
 - B. Institutes and Centers: Dr. Krishna has identified all of the Institutes and Centers at EVMS and be collecting, over the next few weeks, information from all of the Chairs and from the Institute and Center Directors for review by the Dean and the IC sub-committee.
- IV. New business
 - A. Space committee: It was recommended that Dr. Archer discuss with the Dean the current status of space allocation on campus and the role of the Faculty in making decisions regarding this contentious issue.
 - B. Faculty Achievement Awards: Nominations are being sought for the Dean's Faculty Achievement Awards for teaching, research, community and full-time faculty. State teaching award nominations are also being sought through the Awards committee.

 - 2) November 2nd, 2012 deadline for the 2012 Virginia Outstanding Scientist Award. (previously won by Vinik, so also possible)
 - 3) Approximately ~ November 1st/2nd week, 2012 the combined staff/faculty 'awards' ceremony (i.e. Dean's Faculty Achievement Awards ceremony)

C. EVMS/W&M Due diligence committee: The President's office has formed a due diligence committee to look at the myriad of issues that are involved in a potential merger of the two institutions. The Faculty Senate will be represented on the committee by Dr. Krishna.

Ms. Purcell made a presentation to the Senate regarding her efforts to revise the Faculty Handbook. She has asked the Senate to begin with a review/re-write of the information section on the Faculty Senate and the Senate bylaws (last performed about 4 years ago). She will forward electronically these sections to us and we can seek volunteers to tackle this over the next 8 weeks. There are 6 additional sections that she would like Senate input regarding: Process for revising Faculty policies; Grounds for dismissal of Faculty; Sabbatical leave/Fringe benefits/definition of Faculty status (full-time and part-time employment as viewed by Human Resources); Conflict of interest; Consulting policy and Faculty Grievance policy.
