### REPORT FROM VICE PRESIDENT OF DIVERSITY AND INCLUSION

Dr. Gemeda provided an update on the Strategic Plan Study that was developed in 2019 pertaining to four areas recruitment, community engagement, research training in Diversity and Inclusion. Through the recruitment efforts there have been progress in the mentoring program with Hampton University and Norfolk State University starting with 14 students in 2021 and have grown to 40 students and 13 students accepted by admissions. There is two pilot programs that will expand between NIH and Hampton University. We have nursing research that come over 2 days a week. This is a collaborative effort with ODU. Diversity and Inclusions have 315 staff and faculty which is a 26% increase to help with conflict management. Overall, Diversity and Inclusion is make great progress.

#### REPORT FROM THE VICE DEAN FOR ACADEMIC AFFAIRS

Dr. Flenner provided updates from the School of Medicine.

#### **LCME**

Dr. Flenner stated that the LCME status report was submitted August 31, 2023 and that the LCME committee meets in October 2023. Dr. Veronica Catanese Co-Secretary of the Liaison Committee on Medical Education did a brief on site visit to EVMS campus in August 2023 since the 2020 LCME visit was virtual.

### **ERAS**

# **ASSISTANT VICE DEAN FOR STUDENT AFFAIRS & DIRECTOR OF STUDENT WELLNESS**

Dr. Knight presented a revision for Leave of Absence and Withdrawal Policy, Interim Actions Policy, and Student Events Policy and Guidelines.

- Leave of Absence and Withdrawal Policy
  - This policy defines the conditions and student responsibilities associated with Leaves of Absence (LOA), including voluntary and administrative LOAs, and withdrawals from EVMS.
  - There are two types of LOA:
    - Voluntary LOA when a student takes a LOA to interrupt their studies for a period of two or more weeks but intends to return to EVMS to complete their currently enrolled program.
    - Administrative LOA when a students is placed on a LOA according to the institutional or program, policies or procedures

- LOAs can be granted for up to 12 months. In exceptional circumstances consideration will be given for an extension for up to 24 months with the approval of the program.
- Withdrawal when a student does not intend to complete the enrolled academic program(s) and instead wishes to terminate their enrollment at EVMS. This is does not apply to students' intentions to withdraw from a course.
- Revision of the policy is to clarify the procedures for Administrative LOAs and to incorporate the LOA and Withdrawal processes into one policy.

# Interim Actions Policy

- This policy outlines the process for taking action to mitigate student behaviors that pose an actual or potential risk of harm to EVMS, its employees, students, patients, and property, or when the student's continued presence on campus pending the outcome of a Code of Student Conduct or other administrative process would create a significant disruption to EVMS operations, including that of its academic or research programs.
  - There is a confirmed observance or report from any source to a Student Affairs representative, a Program Director, or a member of the Safety Management and Assessment Response Team (SMART) about a single instance of egregious behavior or a pattern of behavior by a student that is negatively affecting the health or safety of the student or any of the EVMS community, or that is disruptive to the learning environment.
  - A student has been charged with a violation of EVMS policy, including violation of the EVMS Code of Student Conduct, related to an incident of disruptive or disorderly conduct.
  - A student has been charged with a violation of state or federal law involving violence or other serious criminal behavior.

# • Student Events Policy and Guidelines

- This policy outlines the responsibilities of event coordinators of any on-campus or offcampus events.
- EVMS Sponsored Student Events include, but are not limited to, the following types of events:
  - Meetings
  - Guest Speakers
  - Fundraisers (whether for EVMS or non-EVMS entities)
  - Volunteer Activities
  - Co-Sponsored Events
  - Social Events
- EVMS supports students' interests in hosting or meeting with individuals outside of EVMS as part of class, student organization, or national organization events. The following procedures apply to requests to host or meet with non-EVMS individuals, including elected or appointed government officials (local, state, or federal), celebrities, and other high-profile individuals. If students are unsure as to which processes or timeline below applies to their proposed meeting or event, they are encouraged to contact Student Affairs at the start of their planning.
  - Request for any EVMS student events must be submitted to Student Affairs at least 8 weeks in advance and approved before initiating contact with "individuals" or "group".
  - Always contact Students Affairs if you are unsure whether the event is EVMS sponsored or not.

### REPORT FROM THE VICE PRESIDENT AND DEAN, SCHOOL OF HEALTH PROFESSIONS

Dr. Combs provided updates from the School of Health Professions.

- School of Health Professions Enrollment is down 5%. Project enrollment 850. It is 2.2 million down to do offset delayed hires. Plan is to work on the marketing of this efforts.
- Last fall the BOV approved the development of 8 new degree programs that are collaborations between EVMS and ODU. Since that time the decision was reached to delay the Doctor of Public Health degree pending the development of the ONE School of Public Health and to forego the development of the Post-Professional Doctor of Occupational Therapy and Master of Science in Nutrition programs.
  - Five programs that have been developed and submitted to SACSCOC are:
    - Doctor of Occupational Therapy 10 students
    - Doctor of Athletic Training
    - Master of Molecular Diagnostics
    - Doctor of Applied Science in Kinesiology
    - Doctor of Philosophy in Nursing Science

# **Program Revisions**

The Doctor of Medical Sciences program proposes a change from a two-year to a one-year program and offering of two derivative graduate certificates- Clinical Leadership and Administration and Educational Leadership and Administration. There were 5 DMSC programs in the country originally with it being modified at EVMS. Requirement of three courses over the semesters.

ACTION: Upon a motion duly made and seconded, the Academic and Student Affairs Committee unanimously voted to recommend the above proposal to change the Doctor of Medical Sciences program from a two-year program to a one-year program, with the addition of two derivative graduate certificates in Clinical Leadership and Administration and Educational Leadership and Administration as presented at the meeting. Further, the committee requested that the Board of Visitors at their September 19, 2023 meeting consider this recommendation for approval.

The Reproductive Clinical Sciences program proposes to establish a training center based on an expansion of its existing hands-on training in IVF technologies. This center responds to a growing national need for technicians trained in the latest IF technologies.

ACTION: Upon a motion duly made and seconded, the Academic and Student Affairs Committee unanimously voted to recommend for the development of The Center for In Vitro Fertilization (IVF) Training as presented at the meeting. Further, the committee requested that the Board of Visitors at their September 19, 2023 meeting consider this recommendation for approval.
