## CALL TO ORDER

Dr. Bruce Waldholtz, Rector, called the meeting to order at 1:00pm after noting a quorum was present.

In a lunch presentation prior to the Board meeting, Dr. Frank Counselman, Vice Dean for Graduate Medical Education, provided an overview of Graduate Medical Education noting the number of Training Programs, Residency Programs and Fellowships at EVMS. He discussed the accreditation status, provided a summary of the National Residency Matching Program and reviewed results of the ACGME Resident/Fellow Survey.

## **APPROVAL OF MINUTES**

Upon a motion made and seconded, the minutes of March 21, 2023, were approved as distributed.

## REPORT OF THE PRESIDENT AND PROVOST

Dr. Alfred Abuhamad, President and Provost, provided recommendations for appointments and promotions at the Assistant Professor and Instructor level, and presented them to the Board for action.

**RESOLVED**, that upon a motion duly made and seconded, the Board unanimously approved the recommendations for faculty appointments and promotions, at the level of Assistant Professor and Instructor.

Dr. Abuhamad recommended Dr. Marybeth Hughes to be named the Margaret Moore Hall Chair in Surgical Oncology.

**RESOLVED**, that upon a motion duly made and seconded, the Board unanimously approved the recommendation of Dr. Marybeth Hughes to be named the Margaret Moore Hall Chair in Surgical Oncology.

Dr. Abuhamad spoke with the Board regarding the Commonwealth of Virginia Deficit Provision Acknowledgement which was distributed with the Board meeting materials to each Board member. Section 4-3.01 of the 2016 Appropriation Act prohibits agencies from obligating or expending general fund amounts in excess of appropriations or obligating or expending at a rate that would result in expenditures in excess of non-general fund revenue collections and appropriations, without prior approval by the Governor. This form must be signed by the President and provided to the Board annually.

Dr. Abuhamad reviewed information provided to the Board in advance regarding the Termination of Cash Balance Pension Plan and brought it to the Board for approval.

**RESOLVED,** that upon a motion duly made and seconded, the Board unanimously approved to terminate the Cash Balance Pension Plan as presented.

## **COMMITTEE REPORTS**

### FINANCE COMMITTEE

Rear Admiral Robert Bianchi, Chair, reported on the Finance Committee meeting held this morning. The April financial results were reviewed and they were consistent with previous months, noting the net proceeds from the sale of Smith-Rogers Hall, as well as a portion from the Sentara Affiliation Agreement, were included in this month. The core net excess is currently \$670,000 which is mostly due to salary and fringe savings from vacant positions. Departmental reserves have a net excess of \$10.9 million and this is mostly due to transfers from EVMS reserves for a startup package for the

OB/GYN Chair. The clinical enterprise operating margin is \$10.3 million which is \$3.2 million less than budgeted. All bond covenants were met.

Ms. Helen Heselius presented highlights of the EVMS FY24 proposed operating budget. The budget is projected to be \$308 million which is an increase of \$15 million. Ms. Heselius noted a budget revision will be presented if integration with Old Dominion University occurs mid-year. The highlights of this year's budget included unrestricted funds from the Sentara Affiliation Agreement, a continued 5% Departmental budget reduction and a net operating support from EVMS Reserves of \$5 million. A Municipal Subsidies increase of \$165,000 was discussed, along with an increase in auxiliary enterprises income and a decrease in clinical support. A copy of the proposed budget package was distributed to Board members for review prior to today's meeting.

Rear Admiral Bianchi requested approval for the FY24 Operating Budget.

**RESOLVED,** that upon recommendation of the Finance Committee, the Board unanimously approved the FY2024 Operating Budget as presented.

### ACADEMIC AND STUDENT AFFAIRS COMMITTEE
