CALL TO ORDER

Dr. Bruce Waldholtz, Rector, called the meeting to order at 1:00pm after noting a quorum was present.

In a lunch presentation prior to the Board meeting, Connie McKenzie introduced Brad Waitzer. Mr. Waitzer is challenging the community to close the scholarship gap for EVMS medical students. For every dollar invested in MD scholarships through June 30, 2023, Mr. Waitzer will match the funding \$0.50 per \$1.00 up to \$1 million. Dr. Ron Flenner, Vice Dean for Academic Affairs, briefed the Board on the 2023 Match Day results.

EVMS Internal Medicine has been accepted as a testing site for a new multi-cancer early detection test, and EVMS has been accepted as a testing site for the American Cancer Society's African American Generational Research in Breast Cancer study, which is scheduled to begin in October 2023.

NEW BUSINESS

Dr. Abuhamad reported that EVMS and NSU recently signed an affiliation agreement to bring the institutions together for faculty collaboration and mentorship of NSU students to assist them in becoming more competitive medical school applicants. EVMS and NSU have committed funds for this collaboration.
